SUBJECT:	Health PEI Protocols

In accordance with legislation, Health PEI Protocols have replaced Medical Directives effective June 26, 2025. Health PEI Protocols will have the same form and function as the former Medical Directives, but with some key updates to their requirements and processes reflected in the <u>Health PEI Protocols Policy</u>. This policy document, developed based on best practices and engagement with key stakeholders, outlines the criteria, definitions, processes, roles and responsibilities, endorsement and approval structures for Health PEI Protocols. This document also sets the direction and process for revision of the existing Medical Directives.

Key changes and updates to the Health PEI Protocol processes are:

- Health PEI Protocols will be developed and implemented across all Health PEI settings (acute and nonacute).
- The requirement of authors to complete either the <u>New Health PEI Protocol Pre-development</u> <u>Checklist</u> or <u>Revision of Existing Health PEI Protocol/Medical Directive Checklist</u> form to obtain support and approval before initiating or reviewing a Health PEI Protocol.
- A new Health PEI Protocol template guide
- The requirement of additional endorsement from the Provincial Nursing Leadership Committee and Provincial Drugs & Therapeutics Committee.
- The Chief Operating Officer and Chief Medical Officer as joint approving bodies.
